# Governor General George P. Garmany, Jr., is our November Speaker



Dr. George P. Garmany, Jr., from Boulder, Colorado, was elected to serve as Governor General of the General Society of Mayflower Descendants in 2017. He has been a member of the Colorado Society since 1994, serving multiple offices there, including two terms as Governor. Prior offices in the General Society include four terms as Surgeon General and one term as Assistant Governor General, with numerous extra appointments during that time. Most recently he served three years chairing the "2020 Committee" which engaged in planning for the activities for the General Society to commemorate the 400th anniversary of the Mayflower voyage.

George earned both his BA and MD degrees at the University of Virginia in Charlottesville. He moved to Colorado for Residency training and practiced Neurology in Boulder for thirty-eight years. He is a Fellow of the American Acad-

# Draft Minutes of the Virginia Mayflower Society's Spring 2019 Luncheon at the Virginia Museum of Fine Arts in Richmond on November 17, 2019

Governor James Maloney called the meeting to order at 12:32 p.m. and welcomed those in attendance.

Acting Elder Sam Williams offered the Invocation and Blessing.

Captain Channing Zucker led the as¬sembly in the Pledge of Allegiance to the Flag of the United States of America.

Governor Maloney introduced those seated at the head table: Jeffrey Allison, Manager of Statewide Programs and Exhibitions and the Paul Mellon Collection Educator at the Virginia Museum of Fine Arts; Guest Speaker Dr. Karen Sherry, Curator of Exhibitions at the Virginia Historical Society; Acting Elder Sam Williams; and Secretary Barbara Carpenter. He introduced Former Governor General and Past Governor Mildred Ramos, and Past Governors Martha Ellen Brockner, Mark Cox, and Elizabeth Diakun, who were also present.

After a recess for luncheon, the meeting reconvened.

Mildred Ramos Scholarship Chairman Marsha Masone announced that the next silent auction to benefit the scholarship fund would be held during the Compact Day Luncheon on November 23 and introduced the 2019 Scholarship Winner, Walker Haynes, a graduating senior from Thomas Jefferson High School, who thanked the Society and offered remarks.

Governor Maloney introduced the afternoon's speaker, Dr. Karen Sherry, whose program was, "Pocahontas versus The Pilgrims: Contesting America's Origin Myth in 19th Century Art and Culture".

The Roll Call of Passengers was read by Historian James Callender.

The minutes of the November Compact Day meeting were approved as published in the newsletter.

Assistant Treasurer Sean Bammon reported on behalf of Treasurer Merle Hazelton total assets of \$97,000, comprised of \$49,000 in the First Union checking account and \$48,000 in the BB&T investment account.

Governor Maloney made the following announcements: the Board of Assistants elected Donald Trausneck as Assistant Secretary and Helen Condict-Case as Assistant Historian; bookmarks from the Plymouth Stamp Club were available urging individuals to contact the United States Postal Service to approve a Plymouth stamp in 2020; the General Society purchased the Plymouth Meeting House by the General Society and invited donations; the General Board of Assistants would meet September 5-8, 2019, in Denver, CO, and those interested in attending should contact him; first-time attendees would assemble at the back of the room at the close of the meeting for a photo; and the next meeting would be held on November 23, 2019, at the Commonwealth Club in Richmond.

Jeffrey Allison provided information on the docent-led tour of the Virginia Museum scheduled to take place at the conclusion of the meeting.

Following the Benediction by Acting Elder Sam Williams, the meeting adjourned at 2:57 p.m.

# **2019 Scholarship Winner**

The winner of the 2019 Mildred Ramos Scholarship was Walker T. Haynes. Mr. Haynes was an honor student at Thomas Jefferson High School for Science and Technology in Arlington, VA, and graduated in June 2019.

The essay topic for the 2019 award was: "The Pilgrims who arrived in 1620 (the Plymouth Colony) and the Puritans who began arriving in 1630 (the Massachusetts Bay Colony) operated independently until 1691. The policies of the two colonies concerning acquiring the land of Native Americans were very different. What were the differences and what caused those differences?"

Walker plans to attend The University of Chicago and will likely major in eco-

nomics, despite other strong interests in history, politics and philosophy.

He has an astonishingly high grade point average, was a 2019 National Merit Semifinalist, was an Eagle Scout leading adventure expeditions in wilderness areas, varsity football player, on the Quiz Bowl Team for TJHSST, volunteered overseas with his church youth group, and somehow has been able to keep his piano skills so finely honed hat he is a three-time Gold Cup winner with eight Superior ratings at the Northern Virginia Music Teachers Festival Spring Piano Festival. And he plays the harmonica.

# **Report on General Board of Assistance Meeting**

The General Board of Assistants of the General Society met this September in Denver. Fifty Member Societies (including Canada and Europe) were there. Members of the Virginia Society attending were Mildred Ramos, former Governor General and Secretary General of the General Society and past Virginia Governor, Barbara Carpenter, our current Secretary and former Secretary General of the General Society and past Governor of the DC Society, and James Maloney, our current Governor.

The Board heard reports from all General Society officers and Committee Chairs. Governor General Garmany reported on his visits to member societies and the General Society's support of the Mashpee Wampanoag Tribe on Cape Cod to gain Congressional relief from the administrative repeal of provisions for its trust lands. He, like virtually all General Officers, spoke of the need to update the General Society's financial policies and resources.

There was much discussion of the need for increase in the amounts charged for applications and dues. Such increases can only be made by the Society's Congress which meets every three years. There has been no increases for some time, and the General Society has had to curtail and defer many expenses in order to prepare for the 2020 celebrations and to process the large increase in applications. Because of financial constraints, the Executive Committee is sometimes meeting by telephone, and a much needed update to the webpage has been delayed.

The Historian General reported on the number of applications through July, and the Executive Director indicated the Society could receive more than 4,500 applications this year. It has been difficult to handle all of these submissions, and finances have prevented additional staff. Steps have been taken to streamline the verification and approval of applications and to lower costs. Even though the cost of processing each application has been reduced to \$125, the \$75 application fee means a loss of \$50 on each application. The anticipated loss in 2019 could be more than \$175,000 (about 10% of the Society's income).

The Treasurer General reported that both income and expenditures had increased over 2018, but that the Society had a net loss of about \$68,000. She spoke of the challenge of "only being able to make important financial decisions every three years [at the Congress]".

The Surgeon General reported on

development of DNA educational packages. The Society has partnered with Family tree DNA, and information has been obtained on eighteen male passengers (the two missing passengers are Richard Warren and Edward Fuller). There are direct lineages for eight female passengers. These direct lineages help to resolve longstanding lineage questions that cannot be solved through documentation.

In addition to the Mayflower House, which the Society has owned for 78 years, the Society now owns the Mayflower Meetinghouse, formerly the First Parish Church (the Pilgrim Memorial Church), and planning for its restoration and conversion and for fund-raising are ongoing.

The General Society has prepared speeches and power points about the 400th anniversary which can be used by state societies, and in addition six "Finding Your Ancestors' lectures are being presented at the Mayflower House this year. The lectures focus on non-Mayflower ancestors and will be posted on the webpage.

# Update - Commemorating the Pilgrims in Stamps and Coin

The last Newsletter contained an article discussing stamps and coins issued at prior anniversaries of the landing at Plymouth. The push in Congress to have a set of gold and silver coins similar to the Jamestown coins issued in 2009 failed. That failure was unfortunate as it would have provided substantial income to the General Society.

The Postal Service has just released information about Commemorative Stamps for 2020, and there will be a stamp to mark the 400th anniversary of the arrival of the Mayflower in Plymouth Harbor.

The U.S. Mint will release a 24 karat, <sup>1</sup>/<sub>4</sub> oz gold coin with a \$10-denomination and an accompanying 1 oz silver medal to mark the quadricentennial of the landing in Plymouth. The coin and medal will be sold both individually and paired in a special set with a Mayflower coin from the Royal Mint of the United Kingdom.

# **Directions to the Commonwealth Club**

The address of The Commonwealth Club is 401 W. Franklin St., Richmond, Va. 23220. Ample free parking is available in the club's own private lots adjacent to its building, as well as on the streets adjacent to the club, where the city's parking meter ordinance is not enforced on Saturdays. The Commonwealth Club's phone number is (804) 648-6543.

### From Washington, D.C. and Fredericksburg

 I-95 South to Exit 76-B, Belvidere. At traffic light turn left onto Leigh Street. At the next traffic light turn right onto Belvidere. Continue south on Belvidere, then turn left at the fifth traffic light onto Franklin Street. The Commonwealth Club is in the second block on your right. Turn right on Stuart Ave and proceed straight for 1 block. The entrance to the parking deck will be straight ahead.

### From Harrisonburg, Waynesboro and Charlottesville

Take I-64 East to I-95 South. Take Exit 76-B (Belvidere), following directions given above.

### From Norfolk, Virginia Beach and Newport News

 Take I-64 West to the Fifth Street Exit (stay in the center lane as you enter downtown Richmond). Proceed 8 blocks, then turn right onto Main Street (one way) and proceed west 9 blocks. Turn into the Commonwealth Club's parking lot (black iron fence with "Commonwealth Club" sign).

### From Petersburg, Hopewell and Emporia

 Traveling north on I-95, take Exit 74-A as you cross the James River onto the 195 Downtown Expressway. Take the exit marked Belvidere (pay toll). At the first traffic light, turn right onto Belvidere and proceed north on Belvidere to the third traffic light. Turn right onto Franklin Street and go two blocks. The Commonwealth Club is on the right.
