

John V. Quarstein is an award winning historian, preservationist, and author. He is director emeritus of the USS MONITOR Center at The Mariners' Museum and Park in Newport News, Virginia. Quarstein previously served for 30



years as the director of the Virginia War Museum during which time he transformed Lee Hall Mansion and Endview Plantation in Newport News, Virginia into museums. The author of over 20 books, his title THE MONITOR BOYS: THE CREW IF THE UNION'S FIRST IRONCLAD won the 2012 Henry Adams Prize for excellence in historical literature. Quarstein has produced, narrated, and written six PBS documentaries, and is the recipient of the 1996 President's Award from the National Trust for Historic Preservation, He lives in the National Register of Historic Places property, the 1757 Herbert House, located near Blackbeard's Point on Sunset Creek in Hampton, Virginia.

### Virginia Society of Mayflower Descendants

Minutes ~ Spring Meeting May 15, 2021 Via Zoom

Governor James Maloney called the meeting to order at 3:03 p.m.

Elder pro tem Samuel Williams offered the Invocation.

Captain Channing Zucker led the assembly in the Pledge of Allegiance to the Flag of the United States of America and the Pilgrim Pledge.

The Governor welcomed those in attendance and the afternoon's speaker, presented the officers in attendance, and reported on a number of items of business. He and the Historian participated in a Zoom meeting with the Governor General and Historian General during which the General Society welcomed its 100,000th member, Virginia member Scott Watson, a Brewster descendant. The Virginia Society donated a brick in honor of Virginia's Historian, James Callender, for the new walkway honoring Society Historians at the Mayflower Society House in Plymouth. Proposed Amendments to the Constitution and Bylaws would be printed in the fall newsletter and voted on at the November Compact Day Luncheon. Virginia Society dues increased to \$50 to cover the increase in the General Society's per capita assessment, with the General Society's portion increasing from \$15 to \$35 and Virginia's portion decreasing from \$23 to \$15. The General Board of Assistants Special Meeting would take place September 8-11, in Plymouth, MA, and members were welcome to register to attend through the member's side of the GSMD website. Members were asked to contact him or the secretary if they planned to attend.

The Governor introduced Lisa Pennington, Counsellor General and guest speaker, who spoke on the "The Voyage that Made a Nation: the Story of the Mayflower 1620-2020."

On a motion by Brantley Knowles, seconded by Lee Woody, the minutes of the November 2019 meeting were approved as published in the spring 2020 newsletter.

Governor Maloney made announcements. The next meeting would be the Compact Day Luncheon to be held in person on November 20, 2021, at the Commonwealth Club in Richmond. The Board of Assistants elected Peter Broadbent as Counsellor and Deborah Misiag as Co-Historian to complete the 2018-2021 term. A nominating committee consisting of Lee Woody, Mark Cox, Martha Ellen Brockner, and James Callendar was appointed and would report at the November meeting. Members interested in serving as an officer or chairman were invited to contact the Governor. Officer reports were included in the newsletter, and due to the anticipated length of the meeting, were not included on the meeting's agenda.

Following the Benediction offered by Elder *pro tem* Samuel Williams, the meeting adjourned at 4:08 p.m.

### The General Society's 100,000th member, Our New Members & Honoring Our Historian

As the 400th anniversary of the landing of the Pilgrims approached, The General Society struggled to keep up with membership applications from all over the country. Each successful new applicant is assigned a number based upon the order in which his application was approved. The Virginia Society's long serving Surgeon, Dr. Arthur G Gower, III, is our member with the earliest approval; he was the 23,062th applicant to be approved. One of our newest members shown in this Newsletter's Historian Report is number 100,552.

Earlier this year, as the number of approved applications moved close to six figures, it was decided to celebrate the 100,000th new member of the General Society. By the luck of the draw, that 100,000th member is one of our own. He is Scott Watson, a retiree from the US Army and a Brewster descendant. He lives in Virginia Beach. The fact that he is the 100,000th new member was announced in a Zoom call posted on the General Society's webpage. Those on the Zoom call were the Governor General, the Historian General, our Governor, James Maloney, and our Historian, Jamie Callender.



Scott received a gift certificate to the Mayflower Store and tickets for two for a round trip to Plymouth. He is also featured in the Fall issue of "The Mayflower Quarterly."

Our Newsletter lists new members, and during the tenure of our Historian, Jamie Callender, he and his assistants, have assisted 305 new members achieve approval. Additionally during the same period they processed an additional 129 approved supplemental applications. Currently, 33 applications and 36 supplementals are pending in Plymouth.



After almost five years, Jamie Callender is stepping down as our Historian. The General Society created a Commemorative Historian Brick Walkway program for a new pathway to be

laid along the garden side of the Genealogy Research Library to recognize and thank historians, past and present, for their significant service to our Society. In appreciation of his services to our Society, our Board purchased a brick for Jamie showing his name and his years as our historian.


### Historian's Report

### Whence The Pilgrim Pledge?

One of my duties as the Society Captain is to place The Pilgrim Pledge at each place setting at our luncheons and to lead us in reciting it. With the supply of cards running low after our 2019 Compact luncheon, I needed to order a new supply. Before placing the order, I thought it would be good to confirm that we had the correct wording. What better way to do that than to contact our national headquarters in Plymouth. I called and posed my question to the lady I with whom spoke; what is the official version? She passed on my request to a staff member.. I received a return call a few days later. I was told said is no official version. I asked her when it originated. She said they did not have that information.

On to the internet. I Googled it. Up came 15,200,000 results. After searching the first dozen most likely citations, I came upon on a 54-page Wyoming Mayflower Society handbook. There on page 6 was The Pilgrim Pledge followed by the name Maurice H. Thatcher. Might he be its author? I Googled him. He was a lawyer. He served as a U.S. Congressman from Kentucky for five terms. He had previously served as a Military Governor of the Panama Canal Zone. Following his years in Congress he practiced law in Washington, D.C. He passed away in 1973 at the age of 102.

Mr. Thatcher served as Governor of the Society of Mayflower Descendants in the District of Columbia and later as Deputy Governor General and Counsellor of the General Society. Thereafter he was designated Honorary Counsellor General for Life. He also found time to organize the Elder William Brewster Society for which he served as president.

He was honored at a testimonial luncheon of the District of Columbia Society on June 11, 1955. Among the attendees were Senators and Congressmen. One of the latter had the luncheon program read into the Congressional Record. Here is an excerpt:

"The program began with an appropriate invocative service by Mrs. Fletcher Quillian, the Society's elder. Then came the pledge of allegiance to the flag, led by Clarence I. Peckham, captain of the Society. Next came the Pilgrim Pledge, composed by Governor Thatcher, as follows:

### The Pilgrem Pledge

(By Maurice H. Thatcher)

In the name of God, Amen.

I pledge myself to help hold aloft the lamps of civil and religious liberty lighted by the Pilgrims at Plymouth Rock; to recall and cherish the sacrifices and struggles made by them for the common good; to study their lives, deeds, faith, courage, and character, and to draw inspiration therefrom; to emulate their spirit; to be loyal to the flag and institutions of the country whose founding was so greatly aided by their work and wisdom; to do everything within my power to deserve and preserve the heritage; and in all things, and all ways, to profit by the Pilgrim example."

In each of the Pledges I read in various publications, including the one in the Wyoming Society handbook, there were small differences. None matched Mr. Thatcher's in the Congressional Record word-for-word. Now, the one you will recite at our luncheons does.

Our own Society was mentioned in this Congressional Record description of the testimonial. "Among the members and friends of the Thatchers in attendance were a number of members of the Society of Mayflower Descendants in the Commonwealth of Virginia, which was organized by him." The date was January 10, 1950.

### Proposed Amendments to the Constitution and By-Laws

November 2021

This is notice of **PROPOSED AMENDMENTS** to the Constitution and By-Laws of the Society of Mayflower Descendants in the Commonwealth of Virginia as required by CONSTITUTION. AMENDMENTS. ARTICLE XII, and BY-LAWS. AMENDMENTS TO BY-LAWS. Article VI. The following fourteen proposed amendments are to be presented for consideration and action during the Society's Compact Day Luncheon in Richmond, VA, November 20, 2021.

Note: Deletions are in **bold** and insertions are <u>underscored</u>.

**1.** Amend CONSTITUTION. Membership. Article III, Section 2, by inserting "or electronic" in the second sentence after the word "autograph."

Article III, Section 2 currently reads:

"Application for membership shall be made in writing and shall be accompanied by the entrance fees. The application shall bear the autograph signature of the candidate. The Historian shall report that lineage papers are correct and approved by the Historian General."

As amended, Article III, Section 2 will read:

"Application for membership shall be made in writing and shall be accompanied by the entrance fees. The application shall bear the autograph or electronic signature of the candidate. The Historian shall report that lineage papers are correct and approved by the Historian General."

Rationale: To align with General Society policy.

**2.** Amend CONSTITUTION, Articles III, Section 3 and Article IV, Section 1, by replacing the word "Historian" with "an Historian, or co-Historians who for purposes of the Constitution and Bylaws will be considered the Historian."

Article III, Section 3 currently reads:

"Every approval by the Historian shall be void unless the lineage papers shall be filed by the applicant, properly filled out, within nine months after the same shall have been sent him."

As amended, Article III, Section 3 will read:

"Every approval by <u>an</u> Historian, <u>or co-Historians who for</u> <u>purposes of the Constitution and Bylaws will be considered the Historian</u>, shall be void unless the lineage papers shall be filed by the applicant, properly filled out, within nine months after the same shall have been sent him."

Article IV, Section 1 currently reads:

"The officers of the Society shall be Governor, Deputy Governor, Secretary, one or more Assistant Secretaries, Treasurer, one or more Assistant Treasurers, Historian, one or more Assistant Historians, Elder, Captain, Librarian, Counsellor, and Surgeon."

As amended, Article IV, Section 1 will read:

"The officers of the Society shall be Governor, Deputy Governor, Secretary, one or more Assistant Secretaries, Treasurer, one or more Assistant Treasurers, an Historian, or co-Historians who for purposes of the Constitution and Bylaws will be considered the Historian, one or more Assistant Historians, Elder, Captain, Librarian, Counsellor, and Surgeon."

A conforming change will be made to Article II, Section 7 of the By-Laws.

Article II, Section 7 of the By-Laws currently reads:

"The Historian shall examine and report on all lineage papers of applicants, shall be custodian of all blank applications, shall maintain a record of approved lineage papers, both original and supplemental, and shall perform any other duties assigned by the Board of Assistants. The Historian, as Society genealogist, shall advise and assist prospective members in completing application requirements, shall examine and approve all membership applications, and shall submit said approved applications to the Historian General of the General Society for final approval."

As amended, Article II, Section 7 of the By-Laws will read:

"The Historian, or one of the co-Historians who for purpose of the Constitution and By-Laws will be considered the Historian, shall examine and report on all lineage papers of applicants, shall be custodian of all blank applications, shall maintain a record of approved lineage papers, both original and supplemental, and shall perform any other duties assigned by the Board of Assistants. The Historian, or one of the co-Historians who for purpose of the Constitution and By-Laws will be considered the Historian, as Society genealogist, shall advise and assist prospective members in completing application requirements, shall examine and approve all membership applications, and shall submit said approved applications to the Historian General of the General Society for final approval."

Rationale: To enable, but not require, the duties of Historian to be shared to reduce the burden on any one person. This change has been urged by our current Historian, James Callender.

3. Amend CONSTITUTION. Officers. Article IV. Section 5. in part, by striking "Any member of the Society, including the Governor and the Deputy Governor, may be nominated for either of these positions on the General Board of Assistants" and inserting in its place, "The Governor shall be the nominee for Assistant General, and the immediate past Governor (or any past Governor if the immediate past Governor is unwilling or unable to serve) shall be the nominee for Deputy Governor General."

Article IV. Section 5. currently reads:

"The Society shall nominate from its members a Deputy Governor General and an Assistant General, their names to be forwarded to the General Congress of the General Society, 8 ● FALL 2021 THE VIRGINIA MAYFLOWER

as provided by Section 6 of Article V of the Constitution of the General Society. If elected, they shall represent the State Society on the General Board of Assistants. Any member of the Society, including the Governor and the Deputy Governor, may be nominated for either of these positions on the General Board of Assistants."

As amended Article IV. Section 5. will read:

"The Society shall nominate from its members a Deputy Governor General and an Assistant General, their names to be forwarded to the General Congress of the General Society, as provided by Section 6 of Article V of the Constitution of the General Society. If elected, they shall represent the State Society on the General Board of Assistants. The Governor shall be the nominee for Assistant General, and the immediate past Governor (or any past Governor if the immediate past Governor is unwilling or unable to serve) shall be the nominee for Deputy Governor General."

Rationale: To clarify long-standing practice and align with Policy 16.

**4.** Amend CONSTITUTION, Article V, Section 4 (b) by replacing the words "on or about the first Saturday in May" with "during May."

Article V, Section 4 (b) currently reads:

"A Spring Meeting of the Society shall be held each year on or about the first Saturday in May at some place agreed upon by the Board of Assistants. The Spring meetings shall be scheduled across the state over the three-year term of a slate of elected officers in the following geographic distribution: one in Northern Virginia, one in the western part of the state, and one in the Tidewater and/or southern part of the state."

As amended, Article V, Section 4 (b) will read:

"A Spring Meeting of the Society shall be held each year <u>during</u> May at some place agreed upon by the Board of Assistants. The Spring meetings shall be scheduled across the state over the three-year term of a slate of elected officers in the following geographic distribution: one in Northern Virginia, one in the western part of the state, and one in the Tidewater and/or southern part of the state."

Rationale: To allow flexibility in scheduling the Spring luncheon.

**5.** Amend CONSTITUTION. Government. Article V. Section 4. (d) by amending and restating the section as follows:

Article V. Section 4. (d) currently reads: "Meetings of the Board of Assistants may be called by the Governor, and shall be called upon the written request of three of its members. Meetings shall be held at least twice in each year."

As amended Article V. Section 4. (d) will read:

"Regular or special meetings of the Board of Assistants may be called by the Governor, and shall be called upon the written request of three of its members, with the time and place of the meeting to be specified in the call or request. Regular meetings shall be held at last twice in each year."

Rationale: To provide for special meetings of the Board of Assistants.

**6.** Amend CONSTITUTION, Government, Article V. Section 4. (e) by amending it and restating it as follows:

Article V, Section 4. (e) currently reads:

"All meetings of the Board of Assistants and of the Society shall be conducted according to the Robert's Rules of Order, Revised."

As amended, Article V. Section 4. (e) will read:

"All meetings of the Society shall be conducted according to the latest edition of *Robert's Rules of Order*, *Newly Revised*, except to the extent to which they are inconsistent with the Constitution, By-Laws or Policies of the Society. All meetings of the Board of Assistants shall be conducted according to the latest edition of *Robert's Rules of Order*, *Newly Revised*, except to the extent to which they are inconsistent with the Constitution, By-Laws or Policies of the Society as applicable for small Board meetings."

Rationale: To align with General Society policy.

7. Amend CONSTITUTION. Government. Article V. Section 4. (f) in part by striking "in writing" after "Ten days' notice shall be sent" and inserting a new second sentence, "Notices of meetings of the Society shall be published in the *Virginia Mayflower* or by electronic communication."

The last sentence in Subsection 4. (f) shall be amended by inserting "<u>electronic communication</u>" after the words "given by."

Article V. Section 4. (f) currently reads:

"Ten days' notice **in writing** shall be sent by the Secretary to the members of all meetings to be held. Notices of meetings of the Board of Assistants may be given by letter or telephone or as otherwise specified by the Board of Assistants."

As amended Article V. Section 4. (f) will read:

"Ten days' notice shall be sent by the Secretary to the members of all meetings of the members to be held. Notices of meetings of the Society shall be published in the *Virginia Mayflower* or by electronic communication. Notices of meetings of the Board of Assistants may be given by electronic communication, letter or telephone or as otherwise specified by the Board of Assistants."

Rationale: To clarify long-standing practice.

**8.** Amend CONSTITUTION. Government. Article V. Section 4. by inserting a new section "h" and renumbering the remaining sections:

As amended, Article V. Section 4. (h) will read:

"The Board of Assistants may permit any or all of its members to participate in a regular or special meeting by, or conduct the meeting through the use of, any means of communication by which all members participating may simultaneously hear each other during the meeting. A member of the Board of Assistants participating in a meeting by this means is deemed to be present in person at the meeting. The Board of Assistants may permit members' meetings to be held in a similar manner when circumstances require this. Voting by the Board of Assistants or the Society's members via e-mail or other

electronic means shall be permitted in accordance with the Society's Policies."

Rationale: To provide for electronic meetings and voting.

**9.** Amend CONSTITUTION. Amendments. Article XII. by inserting after "proposed amendments" in the second paragraph, "recommended by the Board of Assistants"

Article XII. second paragraph currently reads:

"Proposed amendments shall be submitted in writing to the Society membership thirty days prior to the next meeting of the Society. A two-thirds vote of those present and voting shall be required for adoption."

As amended Articles XII. second paragraph will read:

"Proposed amendments <u>recommended by the Board of Assistants</u> shall be submitted in writing to the Society membership thirty days prior to the next meeting of the Society. A two-thirds vote of those present and voting shall be required for adoption."

Rationale: To clarify long-standing practice.

**10.** Amend BY-LAWS. DUTIES OF OFFICERS. Article II. Section 3. by inserting at the end of the section: "The Secretary shall send the Society's annual report to the General Society by February 1 of each year."

Article II. Section 3. currently reads:

"The Secretary shall keep a record of all meetings and proceedings of the Society and of the Board of Assistants; and shall keep a complete list of all members; notify members of their election; and shall send notices to all members of the Society and the Board of Assistants of all meetings to be held. The Secretary shall attend to such correspondence as may be necessary in the discharge of secretarial duties, or as requested by the Governor. The Secretary shall be keeper of the Seal and files of the Society, and shall provide any member who wishes to buy insignia, certificates, rosettes, or other emblems at the price established by the General Society. "

As amended Article II. Section 3. will read:

"The Secretary shall keep a record of all meetings and proceedings of the Society and of the Board of Assistants; and shall keep a complete list of all members; notify members of their election; and shall send notices to all members of the Society and the Board of Assistants of all meetings to be held. The Secretary shall attend to such correspondence as may be necessary in the discharge of secretarial duties, or as requested by the Governor. The Secretary shall be keeper of the Seal and files of the Society, and shall provide any member who wishes to buy insignia, certificates, rosettes, or other emblems at the price established by the General Society. The Secretary shall send the Society's annual report to the General Society by February 1 of each year."

Rationale: To clarify current duties.

**11.** Amend BY-LAWS. DUTIES OF OFFICERS. Article II. Section 5. by inserting at the end of the section, "The Treasurer shall send the Society's annual dues and fees to the General Society by April 1 of each year. A budget shall be approved

annually by the Board of Assistants and administered by the Treasurer."

Article II. Section 5. currently reads:

"The Treasurer shall have charge of all funds belonging to the Society, keeping suit- able books of account; shall charge, collect, and receive all fees, dues, and all other money payable to the Society; and make all necessary disbursements. The Treasurer shall invest, with the approval of the Finance Committee, all special funds of the Society. The Treasurer shall send each member notice of annual dues by November 10 of each preceding year, and a second notice may be sent by January 10. He or she shall render an itemized report of receipts and disbursements at all stated meetings of the Society, and to the Governor or the Board of Assistants at any time such report may be requested. The Treasurer shall, if the Board of Assistants requires it, furnish bond, not in excess of the estimated funds in his or her possession at any time, for the faithful handling of the funds, the premium of such bond to be paid from the funds of the Society."

As amended, Article II. Section 5. will read:

"The Treasurer shall have charge of all funds belonging to the Society, keeping suit- able books of account; shall charge, collect, and receive all fees, dues, and all other money payable to the Society; and make all necessary disbursements. The Treasurer shall invest, with the approval of the Finance Committee, all special funds of the Society. The Treasurer shall send each member notice of annual dues by November 10 of each preceding year, and a second notice may be sent by January 10. He or she shall render an itemized report of receipts and disbursements at all stated meetings of the Society, and to the Governor or the Board of Assistants at any time such report may be requested. The Treasurer shall, if the Board of Assistants requires it, furnish bond, not in excess of the estimated funds in his or her possession at any time, for the faithful handling of the funds, the premium of such bond to be paid from the funds of the Society. The Treasurer shall send the Society's annual dues and fees to the General Society by April 1 of each year. A budget shall be approved annually by the Board of Assistants and administered by the Treasurer." Rationale: To clarify current duties.

**12.** Amend BY-LAWS. DUTIES OF OFFICERS. Article II. by inserting a new section 14:

"Section 14. Society Officers shall report on their activities at all Board of Assistants meetings."

Rationale: To clarify long-standing practice.

**13.** Amend BY-LAWS. DUTIES OF THE BOARD OF ASSISTANTS, Article III. by inserting after "for unexpired terms." a new sentence, "The Board may drop from the Roll any member one year in arrears in payment of dues."

Article III. currently reads:

"The Board of Assistants shall have general charge of the affairs of the Society. The Board shall meet at such times as it shall be called together by the Governor. The Board may fill all vacancies that may occur among the officers for unexpired

terms. The Board may drop from the Roll by a two-thirds vote any member who is prejudicial to the Society, provided such member is given ample opportunity to appear before the Board in his or her own defense."

As amended Article III. will read:

The Board may fill all vacancies that may occur among the officers for unexpired terms. The Board may drop from the Roll any member one year in arrears in payment of dues. The Board may drop from the Roll by a two-thirds vote any member who is prejudicial to the Society, provided such member is given ample opportunity to appear before the Board in his or her own defense."

Rationale: To clarify duties of the Board of Assistants.

14. Amend BY-LAWS. COMMITTEES. Article IV. by inserting at the beginning of the section, "Chairmen and members of", by inserting after the word "Webmaster", "Committee appointments shall be reported to the Board of Assistants.", and by inserting at the end of the section, "At the May meeting of the Board of Assistants in the year of an election, a Nominating Committee shall be appointed by the Governor consisting of the past Governors willing to serve. The senior past Governor shall serve as chairman of the committee. Should fewer than three past Governors be willing or able to serve, the Governor shall appoint a member of the Board of Assistants to serve on the committee. It shall be the duty of the Nominating Committee to recommend to the Society nominees for the offices of Governor, Deputy Governor, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Historian, Assistant Historian, Elder, Captain, Librarian, Counsellor, and Surgeon to serve for three years commencing at the close of the triennial Compact Day meeting.

The Governor shall be an ex-officio member of all committees except the Nominating Committee."

Article IV. currently reads:

Section 1

"Standing committees shall be appointed by the Governor as follows:

- b) Constitution & By-Laws
- c) Education
- d) Finance
- e) Junior Membership
- f) Newsletter Editor
- g) Publicity & Scrapbook

Section 2

The chairmen of standing committees shall be voting members of the Board of Assistants.

#### Section 3

Special committees may be appointed at the discretion of the Governor.

#### Section 4

Committees shall meet at the call of their Chairman, perform such duties as are given them by the Governor, and report through their Chairman at all stated meetings.

As amended, Article IV. will read:
